Review Committee or Individual Assignments

Mayor Brittani Kusel opened the meeting at 7:00 pm by asking Council to review their individual or committee assignments. The purpose of this meeting was to establish a baseline of topics, concerns, or assignments and allow for further discussion.

- 1. <u>Park Cameras:</u> Brittani Kusel is working on finding more information.
- 2. <u>Park Budget for Equipment:</u> Jacque Hayes & Susan Watson will work on reviewing park budget and work on capital improvements for the parks.
- 3. <u>Review Animal Ordinances:</u> A committee of Jacque Hayes and Danielle Woods has been established to review the current animal ordinances along with citizens requests to see if changes should be made.
- 4. <u>Review Landuse and Zoning</u>: Committee members Derek Glosson and Scott Porteus have begun reviewing and are starting with the Industrial Zone.
- 5. <u>Review Camping Ordinance</u>: A homeless person had been camping at the Akron Pond. Questions had been asked of Council leading to more questions by the Council. Susan Watson said she would look into more information and review with Attorney Matt Richardson.
- 6. <u>Pond Status:</u> Council has asked that public information be provided on the status of the Akron Pond Revitilization project.
- 7. <u>Festival Options:</u> Council asked that the tourism committee, Jacque Hayes and Danielle Woods, investigate for events for Akron.
- 8. <u>Ordinance Enforcement:</u> Council discussed ordinance violations noticed throughout Akron and discussed enforcing Akron Municipal Code stronger than has been done in the past. Topics covered parking of campers, trailers, cars, junk piles, grass height.
- 9. <u>Skunk Complaints:</u> Skunk complaints have been made, and no action can be taken by the Town, law enforcement, or the CPW. Citizens with complaints will have to find resolution privately. Harry Slusser is looking into private options to recommend to citizens when they call and complain.
