Golf Cart: A self-propelled vehicle not designed primarily for operation on roadways and that has:

- A design speed of less than twenty (20) miles per hour.
- At least three (3) wheels in contact with the ground.
- An empty weight of not more than one thousand three hundred (1,300) pounds

All-Terrain Vehicle (ATV): A three- or four-wheeled vehicle that travels on low-pressure tires with a seat that is straddled by the rider and with handlebars for steering control.

UTV: A utility task vehicle or utility terrain vehicle designed with a steering wheel and seating between two and six riders.

The operation of Golf Carts/ATV/UTV authorized within the town's corporate limits shall be permitted; provided, however, that this authorization does not permit the operation of golf cars on county roads outside of the town. (Ord. 519, 11-3-2014)

No Golf Cart, ATV, UTV shall be operated in the town without first being registered at Town Hall.

- Upon such registration, the vehicle shall have affixed, as evidence of such registration with stickers on the front & back of vehicle.
- Renewal: Such registration shall be renewed every three years in the same month in which it is first registered. (Ord. 519, 11-3-2014)

The following restrictions shall apply to the operation of Golf Carts/ATVs/UTVs within the town:

- Age restriction: No Golf Cart, ATV, UTV shall be operated by any person under the age of sixteen (16) years.
- Driving Privileges Required: No Golf Cart, ATV, UTV shall be operated by any person unless such person holds valid driving privileges pursuant to Colorado Revised Statutes title 42, or the equivalent under the law of any other jurisdiction within the United States.
- Use on Sidewalk and Trails Prohibited: No Golf Cart, ATV, UTV shall be operated upon any sidewalk, pedestrian trail or recreational facility within the town, whether or not such trail or recreational facility is operated under authority of the town, with the exception of Golf Carts at golf courses and associated golf facilities.
- State And Federal Highway Use Prohibited: No Golf Cart, ATV, UTV shall be operated upon any portion of Colorado Highway 63 (Cedar Avenue) and U.S. Highway 34 (1st Street) within the town's corporate limits.

A Golf Cart, ATV, UTV shall not exceed twenty (20) miles per hour under any circumstances and must follow the rules of the Model Traffic Code.

Every Golf Cart, ATV, UTV operated on town streets shall be insured as provided in section 1409 of the model traffic code.

Time limitation; Headlamps: No Golf Cart, ATV, UTV shall be operated between sunset and sunrise or at any other time when, due to insufficient light or unfavorable atmospheric conditions, persons and vehicles on the street are not clearly discernible at a distance of one thousand feet (1,000') ahead, *unless such Golf Cart, ATV, UTV is equipped and illuminated with headlamps, tail lamps, stop lamps and turn signals as required under part 2 of article 1 of the model traffic code.*

Display Of Slow Moving Vehicle Emblem: Every Golf Cart, ATV, UTV operated upon any road within the town shall at all times display the slow moving vehicle emblem as required under article 1, section 234 of the model traffic code and as further regulated by the provisions of 1 CCR section 204-5. (Ord. 519, 11-3-2014)

Operation Within Roadway: Golf Carts, ATVs, & UTVs shall be operated as close to the right side of the roadway as practicable, exercising due care when approaching, overtaking or passing a standing vehicle or one proceeding in the same direction, or when approaching, overtaking or passing a pedestrian or bicyclist. (Ord. 519, 11-3-2014)
