The Town of Akron is committed to supporting residents facing financial challenges by providing a Utility Rate Relief Program. This initiative offers a 15% base rate reduction on current year water and sewer charges for qualifying residents.

The program aims to assist low-income Town of Akron residents who directly pay the Town for water and sewer services. By reducing utility costs, the Town seeks to alleviate financial burdens and support community well-being.

Program Details

Rate Reduction: Qualified applicants will receive a 15% reduction on base rates only for water and sewer services. This reduction does not apply to charges for excess water usage beyond the base rate. The reduction will apply to charges incurred after application approval and will remain in effect for the remainder of the calendar year.

Qualifications

To qualify for the Utility Rate Relief Program, applicants must meet the following criteria:

- **Billing Account:** The applicant must be listed as an account holder on the Town of Akron water/sewer billing account.
- **LEAP Approval:** The applicant must be approved for participation in the Low-Income Energy Assistance Program (LEAP).
